



H-2B Step by Step Filing Process

Steps to Obtain H2B Certification

Approximate Processing Times

<p>Step 1: Determine Temporary/Seasonal Need/Complete Paperwork</p>	<ul style="list-style-type: none"> • Submit Schedule A (Payroll documents) and Information Sheet to UWT. • Submit all signed paperwork by mid - September
<p>Step 2: Obtain a Prevailing Wage (PWD)</p>	<ul style="list-style-type: none"> • Anytime after 7/1/24 • Typically takes USDOL about 45-60 days to process a PWD.
<p>Step 3: File H-2B Labor Certification Application and Job Order</p>	<ul style="list-style-type: none"> • File 9142 in FLAG portal 75-90 days prior to start date. (ex. File 1/1/25 for a 4/1/25 start date) • A completed Job Order must be submitted to the State Workforce Agency (SWA) in the state the worksite is located in.
<p>Step 4: USDOL First Action</p>	<ul style="list-style-type: none"> • USDOL will either issue a Notice of Acceptance (NOA) or Notice of Deficiency (NOD) • NOA – Will be issued if all regulatory requirements are met. Move forward with next step. • NOD – Will be issued if USDOL needs additional information on anything – payroll records, seasonality, clerical mistakes, etc. UWT will respond the same day (or as soon as additional information is received) to the NOD so that an NOA can be issued. • Please note: NODs are very common for first time employers.

<p>Step 5: Recruitment Period</p>	<ul style="list-style-type: none"> • The employer must conduct recruitment for 15 calendar days from the date the NOA is issued. • Online Job Order that was submitted with the Labor Certification Application will be activated by the SWA until 21 days before the start of need. (UWT will prescreen any applicants and send any eligible candidates to you for further interviewing). • Flier (prepared and sent to you by UWT) will need to be posted for 15 calendar days – pictures submitted to UWT. • Recruitment Report (prepared by UWT) including information regarding previous domestic employees and current applicants must be submitted on day 15 after receiving the NOA
<p>Step 6: Receive Labor Certification</p>	<ul style="list-style-type: none"> • Once the Recruitment Report is submitted to USDOL, they typically issue a Labor Certification within 1-5 business days.
<p>Step 7: Submit to USCIS</p>	<ul style="list-style-type: none"> • UWT will compile a petition and submit an I-129 and all signature pages to USCIS. Petitions are typically sent to USCIS the same day a Labor Certification is received via FedEx overnight delivery. • USCIS has 15 days from the receipt date to make a determination through Premium Processing.

Timeline Example for an April 1, 2025 start date:

<u>File for Prevailing Wage:</u>	Between July 1, 2024 – November 1, 2024
<u>Contracts/Signature Packets Sent Out:</u>	Mid-August – Mid-September
<u>Receive PWD:</u>	Between August 1, 2024 – December 15, 2024
<u>File H2B Job Order with SWA:</u>	January 1, 2025
<u>File 9142 Labor Certification Application:</u>	January 1, 2025
<u>Lottery Results:</u>	January 5-7, 2025
<u>UDSOL First Action:</u>	A Lottery: Early January – Early February B Lottery: Early – Late February C Lottery: Late February – mid-March D Lottery: Mid-March – Late March E Lottery: Late March – Early April F Lottery: Early April – Mid-April G Lottery: Mid-April – Late April
<u>Recruitment Period:</u>	A Lottery: Mid-January – Mid-February B Lottery: Mid - Late February C Lottery: Mid - Late March D Lottery: Late March – Early April E Lottery: Early – Mid April F Lottery: Mid – Late April G Lottery: Late April – Early May
<u>Final Determination Issued/File With USCIS</u>	A Lottery: Mid-January – Mid-February B Lottery: Mid - Late February C Lottery: Mid - Late March D Lottery: Late March – Early April E Lottery: Early – Mid April F Lottery: Mid – Late April G Lottery: Late April – Early May
<u>Final USCIS Approval:</u>	A Lottery: Late January – Late February B Lottery: Late February – Mid-March C Lottery: Late March – Early April D Lottery: Early- Mid April

E Lottery: Mid-Late April

F Lottery: Early May

G Lottery: Mid May

Once USCIS approval is received, H2B workers will be able to begin going to the embassy. Embassy processing times vary by year and by country. Once the worker is embassy approved, flights will be scheduled, and workers may begin arriving on the start date or after.
